ABSTRACT

This study presents a social illness and considered one of the chronic problems among males in all walks of life; the male person delve on their lifestyle, experiences, causes, modes operandi and their transactions of their activities. Qualitative research through case study using purposive sampling. Prior consent were sought prior to the study conducted in the province of Nueva Ecija, with the following criteria at least 15 years old to 22 years of age at the time when they started flesh trading, high school student when they started the activity, good looking person, not known by their parents of their activity, and volunteered and actively participated in the whole process of the study, and no money consideration, any reward or of any kind were collected from the participants. There were ten (10) selected among sixty nine informants were chosen.

Survey questionnaire, observations, interviews and focused group discussion were the instruments used. Frequency count, percentage, and weighted mean were used to represent the real identity of the informants. They vary on their lifestyles, particular in physiological aspects and spiritual aspects.

The causes were socially and environmentally disturbed. They used alluring tricks to deceive their customers. Body languages and groaning sounds or seductive words used to seduce their clients.

Respondents were socialized with other people to conceal their activities. They have vices like drinking alcoholic beverages, smoking cigarettes and also hawked in taking prohibited drugs. They used pimps, give pictures and mobile phone numbers to their prospective customers.

I. INTRODUCTION

Prostitution has continuously been seen as a social problem and there is a need to have better informed policies to address social problems associated with male prostitution. Luiz and Roets¹ describes prostitution as perplexing, the world's oldest profession, that little is actually understood and supported by concrete research, an area clouded in myth, extreme prejudice and pietistic hypocrisy. Prostitutes in these African countries are studied from the prostitutes' own definition of their situation; the prostitutes are able to discuss issues related to their existence in society despite the social stigma attached to prostitution, their motivation to become prostitutes and their experiences with the larger society, especially their clients. The prostitutes are able to discuss what makes it difficult for them to participate adequately in the prevention and control of sexually transmitted diseases and share information on their perceived role in this matter in society. Most importantly, the prostitutes are in a position to inform policies addressing prostitution based on the experiences of prostitutes².

Revised Penal Code, Article 341 (White slave trade)³ imposes a penalty to any person who "shall engage in the business or shall profit by prostitution or shall enlist the services of any other person for the purpose of prostitution." Prostitution is immoral and illegal in the Philippines. It is violation of human dignity, and destroys the positive Filipino values (Zabala 2017)⁴. Perpetrators performed discretely to earn money for their basic necessities. On the other hand, their short time partners wanted self-gratification and sex perversion with another new short time partners. The venue may be in agreed place like hotel, motel, rental house or boarding houses. The mode of payment may be through pimps or procurer less. Few among them or direct from the female (male) perpetrate, enlisting sex worker may be through pimps, procurer less or direct to the sex perpetrators. A study of male escorts reported that, as a result of being generously paid for sex, the escorts felt desired, attractive, empowered, and important; they also developed greater self-confidence and more positive body images over time (Uy et al. 2007)⁵.

In a study conducted, the respondent were financially handicapped, abandoned their families and victims of broken families. Vengeances for their families, self-explorations, self-gratifications and curious in sexual activities. Having a broken relationship with their girlfriends and have been victims of sexual abuse. They feel hopelessness in their life. They were being avoided by their families, neighbors and friends. They were bullied, criticized, humiliated, neglected and ridiculed (Zabala 2017)⁴.

Economic motives are central for both male and female sex workers, but some males are also motivated by the motivated by the potential for sexual adventure that prostitution may offer (van der Poel 1992)⁶.

Objective of the Study

The study focused on the male prostitutes in the province of Nueva Ecija. Specifically, the study sought to reveal the different lifestyles, experiences, causes modus operandi and transactions of the informants.

Prostitution is known to be immoral act of the perpetrator however it is viewed as the oldest profession in the world. Citing etymology prostitution existed as early as 18 century BCE, yet at present still exists. At present, prostitution in other country still exists however they are regulated, and should not be tolerated. There were three types of prostitutes. The first two, sex slaves called *pornai* in Greek and freeborn prostitutes who worked the streets, could be either male or female. The third class included only females. These educated prostitute-entertainers, called *hetaera* in Greek, were some of the wealthiest

women in ancient Greece. State-sanction brothels included mainly inexpensive *pornai*, so that all men, despite income level, could afford to have sex. As Christianity came about prostitution began to be seen as impure. In the 590s Christian Era (CE) Spain had laws punishing women who sold sexual favors by whipping them 300 times and forced them into exile. The men who exploited these women for their 'goods' were never punished. During medieval times, prostitution was so common in large cities that it was hard for kings and queens to outlaw it completely, instead it was heavily regulated. In England, single women could only be prostitutes in brothels were inspected weekly. In the 1300- 1400s in Italy, prostitution was seen as an integral part of life and many state-sponsored brothels were in operation. In the early 1800s in France, a government agency called the Bureau of Morals was created to inspect brothels to be sure that no other criminal activities were taking place. In India, laws have restricted legal prostitution to specific areas in large cities. In 1971, Nevada passed a law allowing its countries to decide to criminalize prostitution. Of the 17 countries, 11 have legalized prostitution. In 1999, Sweden, calling prostitution a crime against women outlawed the buying of sex while still allowing the selling of sex. Prostitution and the sex trade flourish in South Korea just under the country's shiny surface. Despite its illegality, prostitution and the sex trade is so huge that the government once admitted it accounts for as much as 4 percent of South Korea's annual gross domestic product -- about the size of the fishing and agriculture industries combined. South Koreans are the biggest customers of the child sex industry in the region," Seoul, South Korea's largest city, prostitution is widespread and peculiarly civilized -- and a central component of the local business culture. "The majority of top-end -- that is, rich -- businessmen in Seoul are more familiar with sex-industry culture than in a number of other countries," Park wrote. "Sex and power are closely linked in this city. Prostitution as a way of life continued in one form or another over the centuries, including during Japan's occupation of Korea in the first half of the 20th century. In the 21st century, another source of prostitution comes from South Korea's impoverished northern neighbor.

Revised Penal Code, Article 202 Sec. 5 defines prostitute as a woman (man) who, for money or profit, habitually indulges in sexual intercourse or lascivious conduct. Any person found guilty shall be punished by *arresto menor* or a fine not exceeding 200 pesos and in case of recidivism, by *arresto mayor* in its medium period to prison correctional in its minimum period or a fine ranging from 200 pesos to 2,000 pesos or both, in the discretion of the court. Although it is illegal and immoral, lawbreakers do not care the repercussion of their actions.

According to a report by the Consortium against Trafficking of Children and Women for Sexual Exploitation (Catch-Wise): The Catch-Wise report was presented during the international conference on sexual exploitations and it stated that the Philippines is not only the source of 60,000 to 100,000 children for prostitution, but it is now also a transit and destination country for internationally trafficked persons. Data provided by the International Labor Organization also showed that two to 14 percent of the gross domestic product of Indonesia, Malaysia, the Philippines and Thailand comes from sex tourism.

The Philippines, like some other Southeast Asian countries, has an unfortunate reputation for prostitution and sex tourism. It's a huge industry domestically with an estimated 800,000 men, women and, sadly, children working in the trade. The country's international image as a sex destination was largely a result of the US military presence here during and after World War II when "go go" or "girly" bars flourished around the bases at Clark and Subic Bay.

While it's illegal to sell or procure sex, the trade still operates under the guise of entertainment: sex workers are employed as singers, dancers, waitresses or "guest relations officers" in clubs and bars where they are expected to leave with any client who pays a fee. Then there's what are euphemistically dubbed "freelancers", prostitutes that independently cruise bars looking for paying customers.

According to the Coalition Against Trafficking in Women, some fifteen thousand Australian men a year visit Angeles, north of Manila, on sex tours; plenty of Americans, Brits and Europeans join them, while Koreans, Taiwanese and Chinese have developed their own networks, usually based on karaoke bars and restaurants. Manila, Cebu City, Subic Bay and Pasay City are also major sex destinations⁸.

Beirut, Lebanon - In an economically troubled, conservative country where homosexual behavior is taboo, a growing number of men are prostituting them to scrape together a living.

In 2012, a study by the RAND Corporation showed among Lebanese and Syrian sex workers, about 40 percent and 68 percent, respectively, defined themselves as heterosexual. Since the Geneva II peace conference is showing little progress and the Syrian war rages on, poverty-stricken Syrians in Beirut have little chance to see their future improve any time soon.

II. RESEARCH METHOD

The study used qualitative research through case study, to explore on the full picture of the informants engaged in flesh trading. Purposive sampling was employed in selecting the informants. Prior consent was established before the conduct of the study. The researchers emphasized on the confidentiality of all information given by the informants.

Locale of the study

The researchers chose the Province of Nueva Ecija as the setting of the study only those most extreme cases which qualify on the criteria set by the researchers were given priority on the following basis: at least 15 years old at the time when they started flesh trading, high school student when they started learning the activity, good looking person, were not known by their parents of their activity and volunteered and actively participated in the whole process of the study and no money considerations or any rewards or whatsoever.

Informants

Sixty nine informants were qualified in the study who wanted to participate however only ten (10) were chosen, only those most extreme cases which qualify on the criteria set the researchers were given priority on the following basis: at least 15 years old at the time when they started flesh trading, high school student when they started learning the activity, good looking person, were not known by their parents of their activity and volunteered and actively participate in the whole process of the study and no money considerations or any rewards or whatsoever.

Instruments

The main survey questionnaire was adopted from an existing questionnaire prepared by Bernardo A. Zabala Jr., (2017) with the similar study. Some parts/items of the questionnaire were revised by the researchers.

The researchers collected and collated all the needed facts and information required in the study. It utilized survey questionnaire, interviews, observation and focused group discussion. Frequency count, percentage, and weighted weighted mean were used. Pseudo name was used to represent the real identity of the informants. Other sources in gathering data included were their friends who were engaged in the same activity, pimps, by standers, old and prospective customers, immediate members of their family and other concerned citizen in their community.

III. RESULTS AND DISCUSSION

Profile

Among the informants there were two (2) aged 22, one (1) aged 21, one (1) aged 20, two (2) aged 19, one (1) aged 18, one (1) aged 17, one (1) aged 16, and one (1) aged 15. The informants have varied ages, the oldest was 22 and the youngest was 15 years old. Ages 22 and 20 were most frequencies ages, because they possess better body built and charisma to seduce their clients and had a better communicative skills and tricks.

All informants are single. Nine are male and one is bisexual.

Lifestyles: Physiological Aspects

"Strongly Agree" was the answer from these statements, "I brush my teeth before the activity", WM=5. "Maintain personal hygiene", WM=4.90. "I take a bath". WM=4.70.

"Agree" was the answer to these statements, "Wearing seductive underwear", WM=3.30 and "Use condom/safe sex", WM=4.00.

"Moderately Agree" was the answer to these statements, "Wearing sexy t-shirt/body fit", WM=3.20 and "Exercise regularly", WM=2.70.

"Disagree" was the answer to these statements, "Wearing shades", WM=2.50 and "Go to gym to shape body", WM=2.50.

It shows that their lifestyles in preparing their alluring tricks were not similar to each other's; it varies depending on their interest.

They were observed to have a good body figure, a handsome faces. Body figure was their asset to attract customers.

Since the respondents were looked matured their body language can allure their customers. During the interview when asked how would you allure your customers? Some of them said "I let them do whatever they want in my body" or "I make sure that they will be satisfied in my body". Some preferred their client to blow job them and by seducing client by groaning sounds or seductive words.

In the focused group discussion they revealed that their customers were satisfied looking at their body. Some said "because of my perfect body even without sex they were already satisfied".

During the focused group discussion among their customers revealed that were their first sex experience, were satisfied and longing to come back if they have money. Some feel enjoyed and satisfied from their sex experiences.

Social Aspects

"Agree" was the answer to the statements: "I am influenced by friends who were already engaged in prostitution", WM=4.0 and "Technology and gadgets help me become aware about sex", WM=3.6.

"Moderately Agree" was the answer to the statements: "Have many vices such as drinking, smoking and using prohibited drugs", WM=3.00, "I was encouraged by obscene and pornographic materials", WM=2.90 and "Always outside at home late at night with friends in the business", WM=2.60.

"Moderately Agree" was the answer to the statements: "Have many vices such as drinking, smoking and using prohibited drugs", WM=3.00, "I was encouraged by obscene and pornographic materials", WM=2.90 and "Always outside at home late at night with friends in the business", WM=2.60.

“Disagree” was the answer to the statements: “Mingling with the same people with the same preference and attend party to meet new friends” WM=2.3 and “I am a member of a broken family”, WM=1.90.

Majority of the respondents concealed their activity by socializing with other people. They have vices like drinking, smoking and mingling with each other people. These were their social activities.

As observed, they were sociable. They mingled and socialized with their peers and friends. They smoke cigarette, drink liquor and alcoholic beverage. Some admitted taking prohibited drugs but they were doing it secretly.

Interviews revealed that they were open for invitations in any occasions. They used pimps, gave pictures, and mobile phone numbers to their customers.

During the focused group discussion they said that socializing with different groups were welcome to them. They were open because they could look for new customers.

On financial Aspect

“Strongly Agree” was their answer on the following statement: “I know that my prostitution give easy money” WM=4.40.

“Agree” was their answer on the following statement: “I want to augment my income”, WM=4.0, “I want to buy things that I want. (gadgets, clothes, etc)”, WM=3.80 and “I want to help my family”, WM=3.40.

“Moderately Agree” was their answer on the statement: “My family is very poor”, WM=2.90.

“Disagree” was their answer on the statement: “I enter prostitution because I want to support my studies”, WM=1.90.

“Strongly Disagree” was the answer to the following statement: “I don’t have any job”, WM=1.70 and “I do not know other job”, WM=1.70.

Majority of the respondents were the prostitution give easy money.

Interview uncovered that they wanted instant money to buy personal belongings that they needed. They admitted that they engage with selected customers to make them satisfied and gratified. They needed money to help their family. They want to augment their income. They knew their activities as immoral but they could not stop because they needed money.

Observation among the respondents revealed that whenever they have money they buy unnecessary personal belongings, and accessories. Sometimes they buy the things that they want.

During focused group discussion the respondents when asked on money matters they revealed that some of their earned money was just enough for themselves and luxury, other said that they gave some earning to their parents and younger siblings. Some said they kept them in their wallet. Some said they used for 5-6 or various investment.

Psychological aspects

“Moderately Agree” was the answer to these statements: “Feel perverted if they attracted to their client”, WM=3. “Sexually addicted”, WM=3. “Curiosity of having sexual intercourse”, WM=2.80. “Having broken relationship with girlfriend”, WM=2.80. “Feeling of hopelessness in life”, WM=2.60.

“Strongly Disagree” was the answer to these statements: “Rebellious against my parents”, WM=1.40 and “Victim of sexual abuse” WM=1.30.

Majority of the respondents reasoned out that they were psychologically affected having feel perverted if they attracted to their client, sexually addicted, curious in sexual activities, broken relationship with their girlfriend and feeling of hopelessness. They perceived that they have no more brighter future.

During the interview when asked if they were bullied by their peers, friends and their adversaries they answered that they were not distributed but deep in their heart and in their mind they were severely affected, they just keep silent whatever comment they heard and received.

During focused group discussion when asked if they were bothered of what they were doing? Some of them somehow they repented, some were silent, and some smiled, some said they would return to their family if they are no longer interested in sex trading and return to normal life.

As observed, the respondents did not mind the bullying they received and experienced from any group such as adversaries, friends, peers and their relatives. Some said “I am crazy for what I am doing” I like it very much”.

On spiritual aspects

“Strongly Agree” was the answer to these statements: “Praying”, WM=4.3.

“Moderately Agree” was the answer to these statements: “I don’t attend mass”, WM=3.10. “I consider prostitution are for females only”, WM=2.80.

“Disagree” was the answer to these statements: “I help others from my earning in this job”, WM=2.50, “Read Bible”, WM=2.30 and “Feel that God Abandoned them”, WM=1.80.

Majority of the respondents prayed to God, not hearing mass and consider prostitution are for females only.

During the interview when asked if they have faith in God. All of them they do have fear and believe in God, however they do not have time to attend mass and they do not like to be exposed to the public for they don’t want to be bullied or ridiculed.

During the focused group discussion they admitted that during Sunday morning, they seldom get up early to attend mass because they were asleep, were sleepless during Saturday night because they had customers, they also confided that they do not actively participated in religious activities.

As observed they were drowsy and weak. They looked sleepy and moody.

On causes of prostitution: Social/ environmental factors

They “agreed” that they were: “Influenced by friends who were already engage in prostitution”, WM=4.00.” Technology and gadgets help me become aware about sex”, WM=3.6.

Majority of the respondents were socially and environmentally disturbed by the different situations such as influenced by friends who were already engaged in prostitution. Technology and gadgets help them to become aware about sex.

Interview exposed that they openly admitted that they were pleased, and enjoyed with that they were doing especially when money is the subject matter. They did not heed the advice of their parents, relatives and other members of their family. They enjoyed sex activity and could get easy money from their customers. They wanted sex activity at clean lodging house.

As observed, the respondents were aloof to mingle with other members in the community, sometimes were ashamed to face their peers and relatives, and were bullied by the bystanders.

Focused group discussions bared that they were not bothered being the talked of the town, unfamiliar with their peers and they just kept silent when bullied and ridiculed. They admitted that they are open for any social activities.

Effects of relationships: Family relationship

“Disagree” was the answer to these statements: “My sister(s) know(s) my activity”, WM=2.30,

“My brother(s) know(s) my activity”, WM=2.0, “Not able to see my family regularly because I go home late at night”, WM=1.80 and “My family quarrel me”, WM=1.80.

“Strongly Disagree” was the answer to these statements: “My brothers and sisters were ashamed on the kind of job I have”, WM=1.30. “My family is avoiding me”, WM=1.30. “My family does not trust me anymore”, WM=1.40. “My parents know my activity”, WM=1.60. “My girlfriend knows my activity”, WM=1.60.

Majority of the respondents are trusted by their immediate family members because their family does not know their activity. Even their girlfriend does not know their activity.

The interview revealed that their family doesn’t even know that they are doing and what activity they are into. They were trusted by their parents and their siblings.

Focused group discussion summed up that they secretly hide their activity because they don’t want to be ashamed, abandoned and untrusted by their family. Some later would return to normal life and have family of their own.

Relationship with their friends

“Disagree” was obtained from the statement: “I have limited time with my friends”, WM=2.40.

“Strongly Disagree” was obtained from the statements: “My foes are humiliating me because of the nature of my work”, WM=1.40. “I lost my friends since they discover my activity”, WM=1.50. “My friends are avoiding me”, WM=1.60.

Majority of the respondents were trusted by their close friends because they don’t know what they are doing, they’re avoided by their friend after they discover their activity. Their foes did not humiliate them because of the nature of their work.

During the interview, most of their close friend gave comforting words that soon their mind would change and return back to normal life.

During the focused group discussion it was noticed that respondent’s had contentious and convinced their friends to ask forgiveness from God, parents, friends, relatives and from any person whom they had sinned.

Relationship with the community

“Disagree” was obtained from the statements: “I am the center of attraction”, WM=2.0, “They are avoiding me”, WM=1.80 and “Some of the community members are trying to have sex with me”, WM=2.00.

“Strongly Disagree” was obtained from the statements: “The residents humiliate me”, WM=1.40. “They neglect me when I am visiting their home”, WM=1.60.

Majority of the respondents were not humiliated by the residence. They are not neglected by the residents. The community members didn’t know the activity that they are into.

Interview results from the community revealed that they don’t know that the respondents are in that activity.

Focused group discussion revealed that they did not want the activities of the respondents. They were sometimes bullied, humiliated and disregarded. The rest of the community did not mind what they were doing.

As observed, the respondents were taken for granted in the community. They were sometimes bullied, humiliated and even ridiculed.

Modus operandi to attract customers

“Agree” was the answer to the statements: “I use friend’s referral”, WM=3.80. “I give my number to be able to contact me”, WM=3.50.

“Moderately Agree” was the answer to the statements: “I am directly asking them if they want to have sex with me”, WM=2.90, “I am wearing short and attractive clothes”, WM=2.70 and “I give them a wink”, WM=2.70.

“Disagree” was the answer to these statements: “I use pimps”, WM=2.30 and “Stay in malls to search clients”, WM=1.80.

“Strongly Disagree” was the answer to these statements: “Stay in the movie houses”, WM=1.40, “Stay in male comfort room”, WM=1.30 and “I post attractive pictures in social media”, WM=1.20.

Majority of the respondents used friend’s referral. They gave their number to their client to be able to contact them. As disclosed during the interview, a customer said “I directly asked him if he want to have sex me”. Other customer said “I got attracted when he showed his body and smile at me”. Their modus operandi is very effective.

During focused group discussion respondents had their stories on how they convinced their customers. Most of them said their “gifted body parts” were their assets, some said their attractive bodies, while others gave their cell phone number to convince them to do sexual acts.

As observed both the respondents and customers had common understanding.

Transactions with their customers

“Agree” was the answer to the statement: “I let them to be in the hotel first then I will follow in the room”, WM=3.50.

“Moderately Agree” was the answer to the following statements: “I offer them low prices amounting to 500 pesos per session”, WM=3.2 and “I am offering them of three hours of full satisfaction”, WM=3.3.

“Disagree” was the answer to the following statements: “I do transaction through social media like facebook”, WM=2.00 and “Eyeball or blind date”, WM=2.0.

“Strongly Disagree” was the answer to the following statements: “They will pay me first before I go with them”, WM=1.50 and “I don’t perform if they do not pay me first”, WM=1.50.

Majority of the respondents had varied styles in transaction. They let them their client to be in the hotel first then they will follow in the room. The interview revealed that asking payment first before doing sexual activities were their demand.

During the surveillance with the different respondents their styles and reactions on how they convinced their customers varied, it was noticed and observed that they had different styles in wearing clothes and accessories, and body language in the place and where they could display their alluring stance. Sometimes they were victims of customers running away after sexual intercourse.

During the focused group discussion both the respondents and customers were amenable of what they agreed upon. The respondents demanded payment first before sex which the customers heeded on the request especially when they were new customers.

It was observed that meeting of the mind is necessary. Signed language was noticed between them.

Performance made by the respondents

“Strongly Agree” was the answer to these statements: “I am more aggressive with male partner”, WM=4.70. “I make sure that they will satisfy in my body”, WM=4.50. “I let them do whatever they want in my body”, WM=4.40, “I seduce my client by groaning sounds or seductive words”, WM=4.40 and “I only allow my client to blow job me”, WM=4.30.

“Agree” was the answer to these statements: “I let them kiss romance, caress and hug me”, WM=4, “I am willing to give anal intercourse. (when I am on the top)”, WM=4, “I am willing for a male to female sex show”, WM=4.0 and “I still do masturbation even I am with this activity”, WM=3.7.

“Moderately Agree” was the answer to these statements: “I let them perform different styles”, WM=3.40, “I am willing for an orgy”, WM=3.0, “I am willing to do oral and anal performance”, WM=3.0, “I prefer to blow job my client”, WM=3.0, “I am willing for male to male sex show”, WM=2.80, “After giving a massage I blow job my client”, 2.70.

“Disagree” was the answer to these statements: “I dance like a macho dancer”, WM=2.50, “I give them full body massage”, WM=2.40 and “I am willing to give anal intercourse. (when I am at the bottom)”, WM=1.90.

“Strongly Disagree” was the answer to the statement: “I experience to give free service”, WM=1.30.
